Summary of Sessions

We have assumed a travel radius of approximately 150 km from the Hamilton, On location. Please contact us directly for a review of costs, if travel is to exceed the radius.

One session (Two Days) For new operators theoretical and practical hands training with up to 8 attendees, all having successfully completed the CTC crane operator certification course, on:

Day One:

In class training for approximately four (7) hours. Each attendee will receive a reference training manual.

The course will cover the operator assessment of risk and evaluation options for movement of loads, we will provide instruction on the best practices and the do's and don'ts of Boom crane activity. We will specifically review the precise load chart for the boom, stabilizers/outriggers, communication/signaling and crane ancillary equipment inspection. The course is an interactive training program that allows individuals to actively participate in the course through open dialogue with the trainer.

The classroom training will be concluded with a written test that will serve to document the information retained by the individuals and signing of a sign-out sheet.

Day Two:

Demonstration of Skills: Hands on proper crane checkout of daily OHS safety inspection requirements performed by each individual. The trainees will be asked to perform a specific task(s) and are appraised on their ability to communicate and control a loaded crane safely. Questions will be answered and more time will be spent with students with less experience than those the instructor has determined are adequately competent. Trainees may leave to go back to their work once they have concluded the practical review. The order in which they are seen by the trainer is up to the customer.

Availability of the student, load, appropriate crane(s) and rigging is essential and must be arranged prior to the session.

The entire course is structured to cover the essential information required by crane operators. Our trainer will direct, as best he can, the course to the specific intricacies of your operation. It is for this reason that some flexibility in terms of the time is appreciated.

The boom crane manufacturer, model number, total boom length and capacity must be provided. In addition, a copy of the operators and maintenance manual is required at least 2 weeks prior to the date of training. If the manuals are not available we can contact the manufacturer and secure one at an extra charge.

Upon successful completion of the course and satisfactory testing, each attendee will be given a Certificate of Crane Operator Proficiency.

There is no substitute for experience, having completed this course the operator will have received the necessary instruction and have been made aware of the rules that are applicable to safe operation. The workers that are new will require additional properly supervised practice under all working conditions that may arise in order to properly imbed the proper reaction in the event of a problem. We recommend that all workers who are not regularly using the equipment be scheduled for practice time on a regular basis.

The length of the course is dependent on the number of students and on the length of question and answer sessions. The session will be held at your facility. The training normally begins early in the morning (typically 7:00 am) and is for a session not exceeding seven (7) hours, alternate times can be arranged and may involve additional costs. All other trainer(s) expenses are covered.

Terms and Conditions:

- ✓ Each additional trainee over the amount quoted will be at a charge of \$ 200.00
- ✓ Prices quoted are subject to change 60 days from date of proposal.
